



## **1. Introduction & Applicability**

These Terms & Conditions (T&Cs) apply to all fixed-price subcontracts and purchase orders issued by FBC Enterprises LLC ("FBC Enterprises") in support of United States Government prime contracts. These clauses are incorporated by reference with the same force and effect as if set forth in full text. Applicability of each clause is subject to the nature of the work, contract value, and whether the items provided are non-commercial, commercial, or COTS.

For product quality, packaging, marking, documentation, and compliance obligations applicable to all suppliers, refer to **Appendix C – Supplier Quality & Compliance Requirements**.

## **2. Definitions**

- **Prime Contract:** The contract between FBC Enterprises and the U.S. Government (or higher-tier contractor).
- **Subcontract:** Any agreement entered into by the SELLER to furnish supplies, materials, or services.
- **Contracting Officer:** The Government official authorized to administer the Prime Contract.
- **Contractor:** FBC Enterprises LLC.
- **Subcontractor / SELLER:** The party identified in the subcontract agreement.
- **Commercial Item / COTS:** As defined in FAR 2.101.

## **3. Incorporated FAR and DFARS Clauses**

FAR and DFARS clauses that are mandatory or applicable based on value thresholds, contract type, or item classification are incorporated by reference. These include, but are not limited to:

### **A. General Contract Administration**

FAR 52.203-6, 52.204-25, 52.209-6, 52.232-40

### **B. Ethics and Business Conduct**

FAR 52.203-12, 52.203-13 (if >\$5.5M & >120 days), 52.203-17



**C. Cost and Pricing (if applicable)**

FAR 52.215-12, 52.215-13, 52.215-14, 52.215-23

**D. Small Business Participation**

FAR 52.219-8, 52.219-9 (if >\$750K, non-small business)

**E. Labor and Equal Opportunity**

FAR 52.222-26, 52.222-35, 52.222-36, 52.222-41, 52.222-50, 52.222-54

**F. Trade Compliance and Country of Origin**

FAR 52.225-1, 52.225-5, 52.225-13

**G. Intellectual Property and Data Rights (if applicable)**

FAR 52.227-1, 52.227-2, 52.227-14

**H. Quality Assurance**

FAR 52.246-2, 52.246-11, 52.246-26

**I. Termination and Default**

FAR 52.249-2, 52.249-8

**J. Cybersecurity and Data Protection**

DFARS 252.204-7012 applies to any subcontract involving the performance of work where the supplier will access, store, process, or transmit Covered Defense Information (CDI) or Controlled Unclassified Information (CUI). Compliance with NIST SP 800-171 safeguards and timely cyber incident reporting are required.

Additional applicable clauses are outlined in **Attachment A: FAR and DFARS Flowdown Matrix.**

## **4. Certifications and Representations**

By accepting this subcontract, SELLER certifies that:

- It is not debarred, suspended, or proposed for debarment.
- It complies with applicable equal opportunity and affirmative action laws, including FAR 52.222-26, 52.222-35, and 52.222-36.
- It complies with DFARS 252.204-7012 where CUI is involved.



- No funds were used to influence federal transactions in violation of FAR 52.203-12.

SELLER must immediately notify FBC Enterprises of any change affecting these representations.

## **5. Communication, Flowdown, and Amendments**

- All communications with the Government must be coordinated through FBC Enterprises.
- SELLER agrees to flow down applicable FAR and DFARS clauses to lower-tier subcontractors.
- SELLER agrees to reasonable contract modifications if required to comply with changes in the Prime Contract.

## **Appendix C: Supplier Quality & Compliance Requirements**

### **Order of Precedence**

- If any requirement(s) in this document conflict with the Purchase Order, the Purchase Order shall take precedence.
- If any requirement(s) in the Purchase Order conflict with associated U.S. Government contract requirements, the contract requirements shall take precedence.

### **Acceptance**

The Supplier's acceptance of this Purchase Order constitutes agreement to all stated terms and conditions, including but not limited to:

- Purchase Order price and quantity
- Delivery terms
- Product specifications
- Quality and regulatory compliance
- Packaging and documentation requirements

### **Acknowledgement and Order Confirmation**

Supplier shall acknowledge receipt of each Purchase Order and confirm acceptance by sending confirmation to: **mary@fbcenterprises.com**

### **Agreement**

Acknowledgment and acceptance of the Purchase Order constitutes a binding agreement between the Supplier and FBC Enterprises. Any changes to the terms must be approved in writing by both parties. FBC Enterprises reserves the right to withdraw a Purchase Order at no cost if requirements are not met.



## **Cancellation of Purchase Order**

If the Supplier becomes aware of any delivery delay beyond the Contract Delivery Date(s), they must:

- Notify FBC Enterprises immediately in writing
- Provide the reason for delay and a proposed revised delivery date
- Understand that revised terms are subject to written approval

Delays, nonconforming product, or deficient documentation may result in cancellation of the Purchase Order at no cost to FBC Enterprises. In such cases, the Supplier may also be liable for additional costs or penalties incurred.

## **Corrections and Exceptions**

- If a correction or exception to a Purchase Order is needed, submit a written request referencing the PO number and related contract.
- Revised Purchase Orders replace all prior versions and must be used moving forward.

## **Flow Down Requirements**

The Supplier must flow down all applicable terms from the Purchase Order to sub-tier suppliers. This includes:

- Technical specifications and drawings
- Key characteristics and safety items
- Regulatory requirements
- FBC Enterprises' customer (government) contract clauses

## **Right of Access**

FBC Enterprises, our customers, and Government representatives reserve the right to access the Supplier's and any sub-tier supplier's relevant facilities, records, and work for inspection or audit purposes. This requirement must be flowed down to all sub-tier suppliers.

## **Government Contracts**

If the order supports a U.S. Government contract, this will be indicated on the Purchase Order along with any applicable **DPAS rating**. In such cases:

- Supplier must comply with **15 CFR 700** (DPAS regulations)
- Product must be **new, unused, and of domestic manufacture**, unless otherwise specified
- Relevant **FAR, DFARS, and DLAD** clauses apply and shall be considered incorporated

## **Counterfeit / Fraudulent Electronic Parts**

If the order includes electronic components or assemblies:

- Supplier must maintain a counterfeit part detection and avoidance system in accordance with **AS6496** and/or **AS5553**
- Supplier must notify FBC Enterprises prior to sourcing from non-authorized distributors
- Supplier systems should align with **DFARS 252.246-7007 and 252.246-7008**, even if not formally flowed down

## **Nonconforming Product**

All delivered product is subject to inspection upon receipt. Product must:

- Meet all applicable specifications, drawings, and Purchase Order terms
- Be free from defects in materials or workmanship

If product is found to be nonconforming:

- FBC Enterprises will notify the Supplier and initiate return and correction
- All costs for removal and return will be the Supplier's responsibility
- The Supplier must immediately disclose any known nonconformance prior to shipment



- The use of “use-as-is” or “repair” dispositions requires FBC Enterprises’ written authorization
- FBC Enterprises reserves the right to request a formal corrective action

### **Prohibited Sources**

Suppliers and sub-tier suppliers may not use sources listed on the **Excluded Parties List System (EPLS)**. Suppliers must verify eligibility status using [SAM.gov](https://sam.gov) in accordance with **FAR 52.209-6**.

### **First Article Inspection (FAI)**

Where specified, FBC Enterprises will require First Article Inspection (FAI) or First Article Testing (FAT). Purchase Orders will identify:

- Location of the inspection
- First piece or full lot qualification
- Reporting requirements, test criteria, and documentation deliverables

Unless otherwise agreed in writing, the Supplier is responsible for the cost of first article activities.

### **Government Source Inspection (GSI)**

If Government Source Inspection is required, the details and inspection point(s) will be clearly stated in the Purchase Order. The Supplier must coordinate with FBC Enterprises to schedule inspection.

### **Certifications and Traceability**

At the time of shipment, the Supplier must provide all certifications and documentation required by the Purchase Order, including:

- Certificates of Conformance
- Test Reports
- Safety Data Sheets (if applicable)
- Full traceability back to the original manufacturer (if Supplier is not the manufacturer)

Records must be retained and made available upon request.



## **Calibration**

Any tools, gages, or equipment used to inspect or verify final product acceptance must be calibrated per the latest version of:

- **ANSI/NCSL Z540.3**
- **ISO 10012-1** or **ISO/IEC 17025**
- And be traceable to the **National Institute of Standards and Technology (NIST)**

## **Shelf Life Materials**

Unless otherwise specified, products requiring shelf life must have **at least 90% shelf life remaining** at the time of delivery.

- Shelf life and cure dates must be clearly labeled on packaging and documented on the certification.

## **Foreign Object Debris (FOD) Control**

Supplier shall maintain a documented **FOD prevention program** appropriate to the product and manufacturing environment to ensure no contamination or debris is introduced into the end item.

## **Marking and Labeling**

Products must be marked/labeled in accordance with:

- The latest revision of the technical drawing
- The government contract (if applicable)
- Any special PO instructions

## **Packaging**

Products shall be packaged to prevent damage, contamination, or corrosion. Unless otherwise stated, packaging must:



- Conform to drawing or Purchase Order requirements
- Comply with applicable **MIL-STD** or **commercial best practices**
- Ensure safe handling through shipping and receiving

### **Hazardous Material**

When applicable, shipments must comply with:

- **RoHS** (Restriction of Hazardous Substances)
- **REACH** (Registration, Evaluation, Authorization and Restriction of Chemicals)

Each chemical shipment must include a **Safety Data Sheet (SDS)**.

### **Export Compliance / ITAR**

If the product is subject to **ITAR**, the Supplier must:

- Comply with all U.S. export regulations under **22 CFR §§ 120–130**
- Clearly identify the part as **"ITAR PART"** on the packing slip and certifications
- Prevent unauthorized transfer or export of controlled information

### **Affirmative Action Compliance**

FBC Enterprises is an **Equal Opportunity Employer**. Suppliers must comply with affirmative action and nondiscrimination laws, including:

- **FAR 52.222-26** Equal Opportunity
- **FAR 52.222-35** Equal Opportunity for Veterans
